Unfortunately, all too often there is a disconnect between what the breeders actually turn out and what actually is winning; therefore the immediate need for complete and accurate breeding and performance stats.

Mark Fredenberg Article



(NAES from time to time asks for interesting articles about a certain aspect of horse law...here's a reply from local Phoenix attorney, Mark Fredenberg, Esq.)

Deaton v. Kentucky Horse Racing Authority, 172 S.W.3d 803 (2004)

Case summary:

Defendant Deaton was a licensed thoroughbred trainer with a contract to train horses owned by Dr. Joseph E. Kutz. One of Dr. Kutz' horses "Explodo Red" had a tendency of expending too much energy prior to his races, (also known as "washing out").

Dr. Kutz considered possible solutions and decided to place Prozac, (a forbidden substance), in liquid glucosamine and provided the mixture to the trainer who in turn administered it to the horse 3 times daily.

On February 17, 2002, "Explodo Red" finished second at Turfway Park. The standard urine testing revealed the Prozac. The trainer, Deaton, was suspended for 150 days.

The court rejected Deaton's assertion that the Prozac was procured and mixed by the owner and held the trainer responsible for failure to rebut the presumption that the trainer was negligent in his failure to safeguard the horse from tampering.

(NAES comment – the USEF and its predecessor the AHSA, worked to hold responsible the person who signs as "trainer." If you sign as trainer you are totally responsible for what may have been illegally administered to the horse when NOT in your custody or in this case administered at the direction of the owner).
